# 2023-2024 ANNUAL REPORT





## Dear **Supporters**

As we reflect on the past year, we are filled with immense pride and gratitude for the progress we have made together. Your unwavering support has enabled us to achieve significant milestones in our mission. With the successful launch of new programs and the deepening of our community impact, we were able to serve nearly 4,000 individuals, providing life-changing treatment and support to some of our most vulnerable community members.

In Gallup, through investment in a new facility, we increased capacity to provide outpatient services and medication assisted treatment. Partnership with the Department of Corrections and the DWI Treatment Court allowed us to reach justice-involved individuals, offer a holistic approach to addressing the root causes of substance use, get clients on the road to recovery, and break the cycle of incarceration. A commitment to hiring Certified Peer Support Workers (CPSWs) has proved invaluable as lived experience and empathy enhances the therapeutic process and fosters a greater sense of trust and understanding with the people we serve.

With continued support of the Brindle Foundation and SAMHSA funding of residential treatment for pregnant and postpartum women with substance use disorder, we've been able to expand the services we offer in our Women & Children's Program including therapeutic childcare, parenting classes, case management, care coordination and psychiatric care. With this funding, we treated 234 women, 20 children and 117 children not in the facility but participating in therapeutic services.

We have also made significant strides in the execution of our four-year strategic plan — the first goal of which is: "Make Recovery Accessible." Accessibility means getting clients the care they need when they need it. In so many cases, treatment success hinges on timing. The window of readiness to seek professional help is often brief. Whether it's an open bed, an interim plan or an outpatient group, services must be available when they're most needed. Over the past couple of years, we've pursued funding opportunities to support expansion that will allow us to do just that. We're thrilled to announce that over the past year, we were awarded several significant multi-year grants that will lay the framework for us to pivot to a new model of care that will help improve long-term recovery outcomes.

Most notably, we received a federal grant to establish a Certified Community Behavioral Health Clinic in Gallup and New Mexico's provisional CCBHC certification which will allow us to also add a clinic in Santa Fe.

With your continued support, we are confident in our ability to create a brighter future for all those affected by substance use disorders. We look forward to the journey ahead and invite you to join us in making a difference.

## Grant **Funding**

We endeavor to address barriers to treatment, eliminate health disparities and drive population-level outcomes for all New Mexicans — especially those severely impacted by historical trauma, unemployment and other socioeconomic factors.

Our focus on the continuum of care model including prevention and recovery, wrap-around navigation services, strong community partnerships, and cultural proficiency has positioned us for sustained growth and expansion. In 2023, we were awarded several grants aligned with our strategic goals of promoting accessibility, improving outcomes and advancing recovery across the region.



## Health Resources and Services Administration (HRSA) Rural Communities Opioid Response Program Medication Assisted Treatment (MAT) Access Grant

We plan to increase access to medication assisted treatment (MAT) and supportive services for the rural populations of McKinley County struggling with opioid use and alcohol use disorders by establishing multiple new treatment sites throughout the region in partnership with Native American Chapter Houses, departments of corrections and by utilizing mobile units.

## SAMHSA Minority AIDS Initiative: Substance Use Disorder Treatment for Racial/Ethnic Minority Populations at High Risk for HIV/AIDS

Santa Fe Recovery Center is currently launching initiatives supported by the SAMHSA Minority AIDS Initiative (MAI) grant, with a focus on addressing HIV and Hepatitis C Virus (HCV) among individuals at high risk for these conditions. SFRC is committed to implementing evidence-based practices tailored to the needs of these individuals, aiming to prevent the spread of HIV and HCV, increase access to testing, and improve access to treatment for both conditions. Additionally, SFRC is dedicated to ensuring rapid screening accessibility and providing support to clients and community members through referrals and linkage to care for treatment and further prevention measures. By collaborating with healthcare providers and community organizations, we aim to reduce the number of new HIV and HCV infections while enhancing overall health outcomes for our clients and community members.

## Substance Abuse and Mental Health Services (SAMHSA) Certified Community Behavioral Health Clinic (CCBHC) Implementation

In September 2023, Santa Fe Recovery Center received the SAMHSA CCBHC Implementation grant. CCBHC is a nationally emerging standard of Medicaid services and an integrated community behavioral health model of care that aims to improve service quality and accessibility. This award allows us to transform our organization into an operating model in alignment with our strategic plan that will provide a much-needed continuum of behavioral health care and supportive services in rural New Mexico and set us up to:

- offer a broader range of services, including prevention, early intervention, enhanced outpatient, and aftercare recovery engagement **beyond residential treatment**
- develop more robust engagement with people and support their **long-term needs**
- establish care coordination with local primary care providers, hospitals, healthcare services, and law enforcement to help clients **navigate the entire range of services**
- broaden our services to improve family engagement and **treat youth and adolescents**
- offer integrated medical, behavioral health, and recovery support services **that meet the complex needs of all individuals**
- provide access to services beyond the four walls of the clinic, such as mobile crisis teams, outreach workers, and emergency or jail diversion



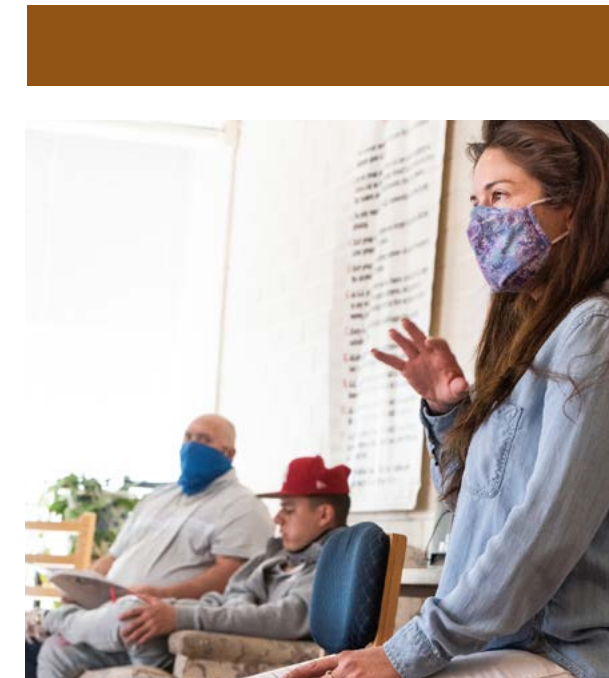

## New Mexico Human Services Department, Behavioral Health Services Division 988 Crisis Response - Mobile Crisis Teams and Crisis Triage Centers for Tribal Communities

With this funding, SFRC is in the process of establishing a 24/7 crisis center in Gallup co-located at Four Corners Detox Recovery Center. The center will operate as a voluntary urgent care center for residents experiencing a mental health or substance use crisis. While at the facility, individuals have the opportunity to decompress in a calm environment for up to 24 hours while our interdisciplinary team of clinicians, social workers and navigators provide immediate, comprehensive, and compassionate care to address the immediate crisis and create a plan to access needed wrap-around services before discharge, including housing needs, social services or substance use treatment.

By providing a range of services from acute crisis intervention to ongoing support, our center will play a crucial role in improving mental health outcomes and enhancing public safety in McKinley County.

# Housing Support

Having a solid support system and safe living environment is a critical part of the recovery process. Before completing our residential programs, our clients work closely with case managers and navigators to plan their next steps. Our Bridge House program is based on a supportive housing model, which combines affordable housing with coordinated services. It provides a supportive, substance-free living situation for individuals who are “stepping down” from residential programs or seeking an alternative to traditional outpatient treatment.

With support from the Affordable Housing Trust Fund, we have been able to assist 117 clients with transitional living support including placement in our Bridge Houses and other sober living facilities as well as costs like utilities, deposits and arrears for those returning to previous living environments.

# Client Story

## A Recent Graduate's Journey Through Recovery

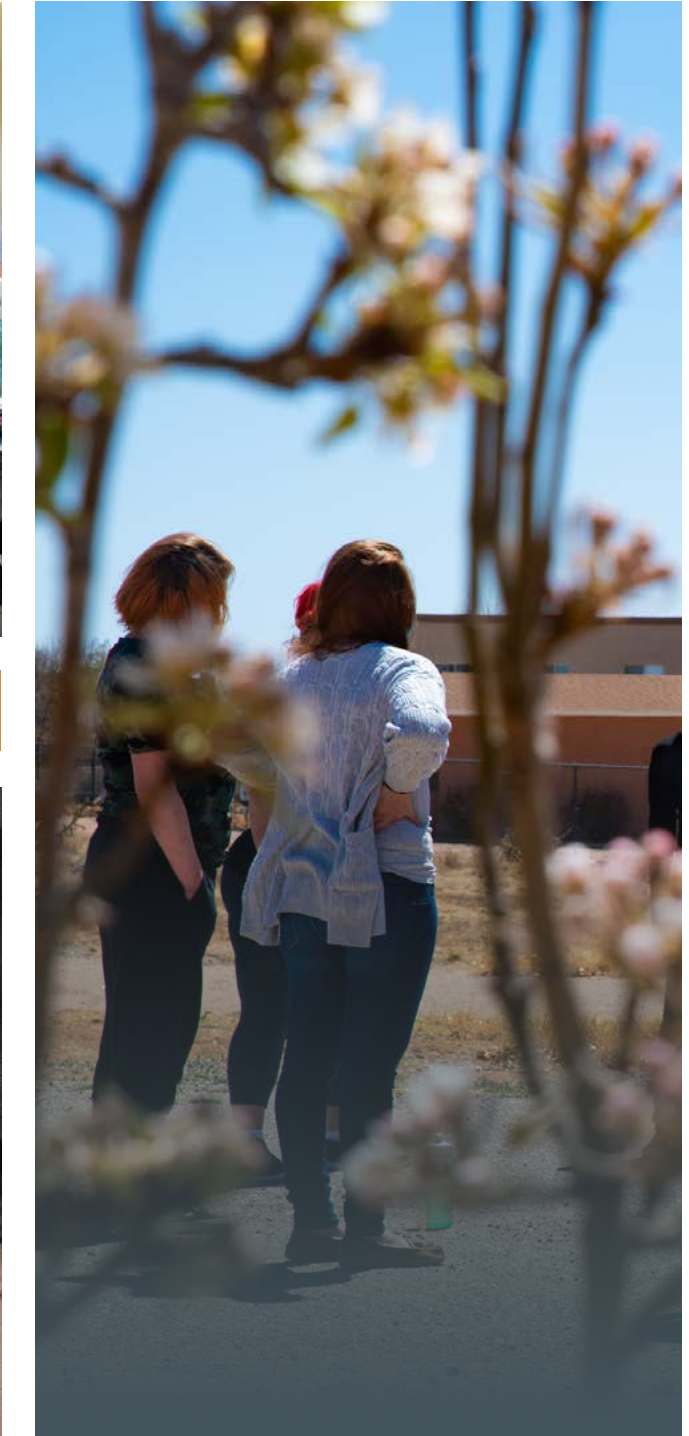
Embarking on a new career path can be overwhelming and at times scary – including new challenges, a new routine and so much new information to learn. A recent graduate of Santa Fe Recovery Center faced all of this when she began her journey to become a vet tech. She also struggled with substance use disorder, which threatened to derail her plans.

Shortly after securing an internship at a local veterinary clinic, our client realized she needed help and entered detox at Santa Fe Recovery Center. She could have chosen to simply focus on her treatment and worry about completing her education and internship at a later date, but she was determined to make it work. After she left detox and settled in our residential program, she re-engaged with her internship.

She faced many challenges in the beginning – ensuring she had enough credit hours, traveling between Santa Fe and Albuquerque to meet her internship obligations and exploring post-internship employment opportunities. She did all of this while completing our 30- and 90-day residential treatment programs and applying for acceptance into our Bridge House program.

She maintained her sobriety, completed her internship and began working full-time at a clinic as a licensed vet tech. She graduated from our Bridge House program one month ahead of her discharge date, applied, and was approved to move into her new apartment, which wouldn't have been possible without AHTF funding.

That same month, she celebrated one year of sobriety. This client is a shining example of the power of commitment and perseverance and the achievements people in recovery are capable of when given a safe place to land and support along the way.

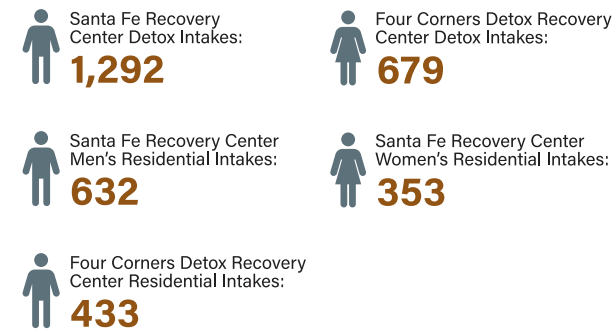
# Our Impact



## Compassionate Treatment

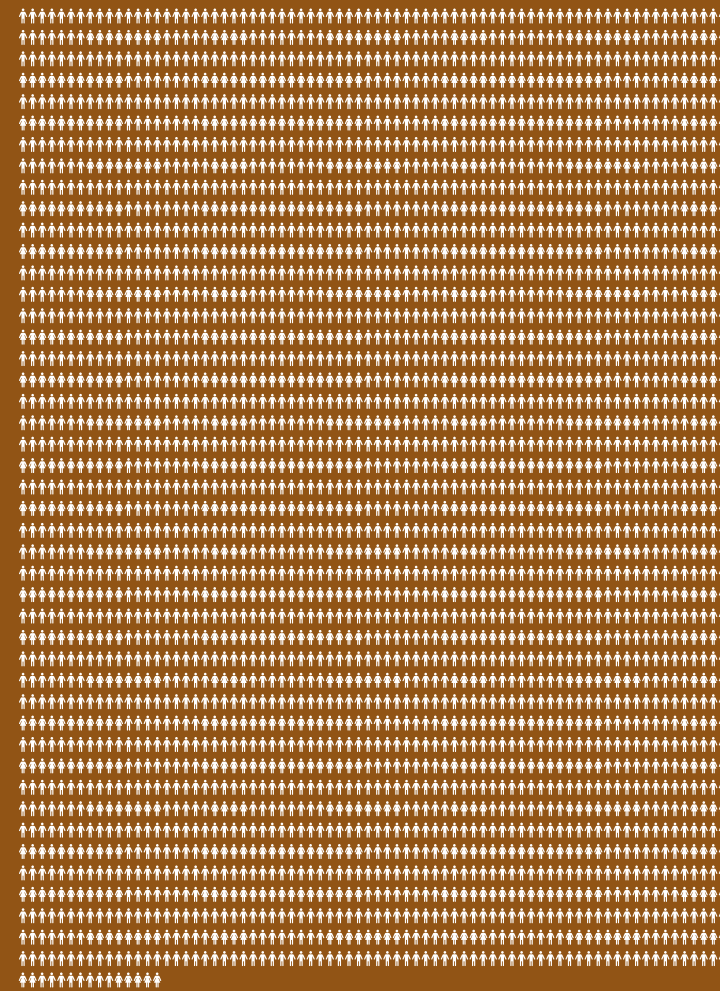
Santa Fe Recovery Center has been providing compassionate treatment to support people throughout their full journey of recovery from substance use disorder since 2005. We're committed to breaking down barriers to treatment and eliminating health disparities for disadvantaged populations severely impacted by historical trauma, unemployment and other socioeconomic factors.

With locations in Santa Fe and Gallup, we provide a full continuum of integrated care including detox, 30- and 90-day residential, outpatient, sober living housing, case management and medication assisted treatment. Our Women & Children's Program in Santa Fe is one of the only residential programs in the state that allows women to bring their children (ages 0-6) into treatment with them.

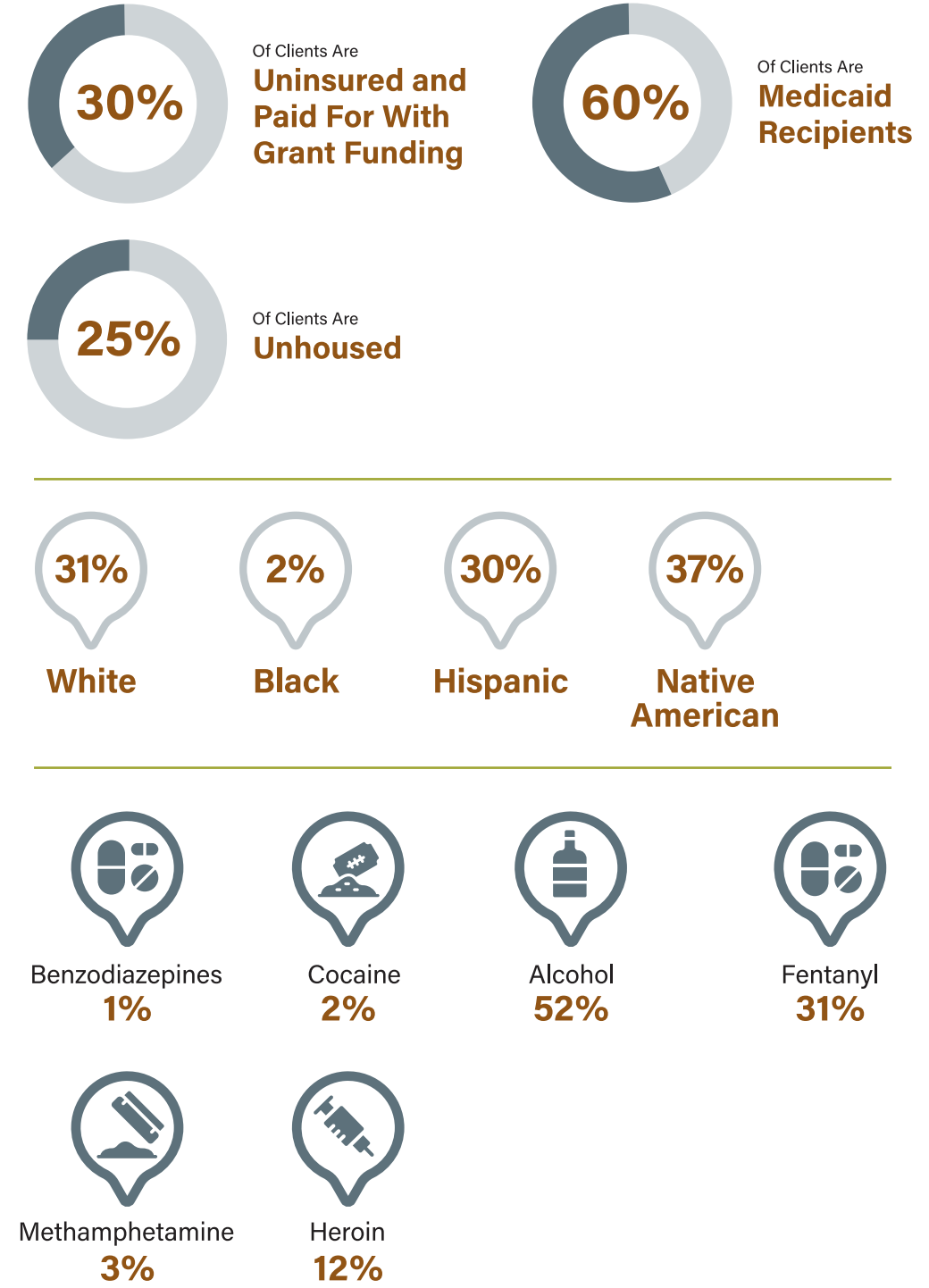


## Total Admission Numbers for All Santa Fe Recovery Center Programs (January - December 2023)

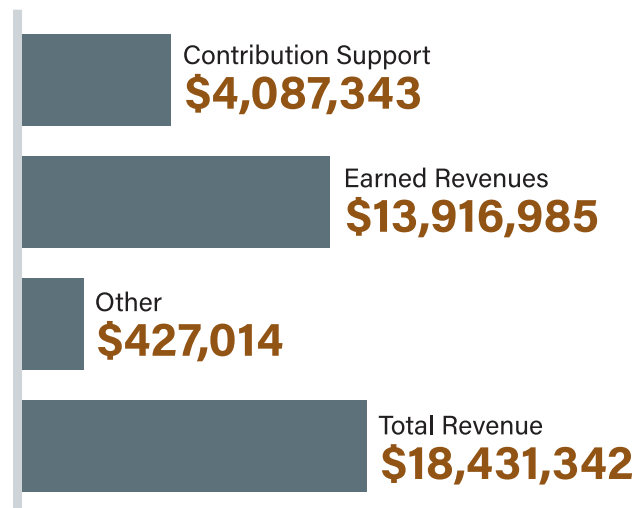

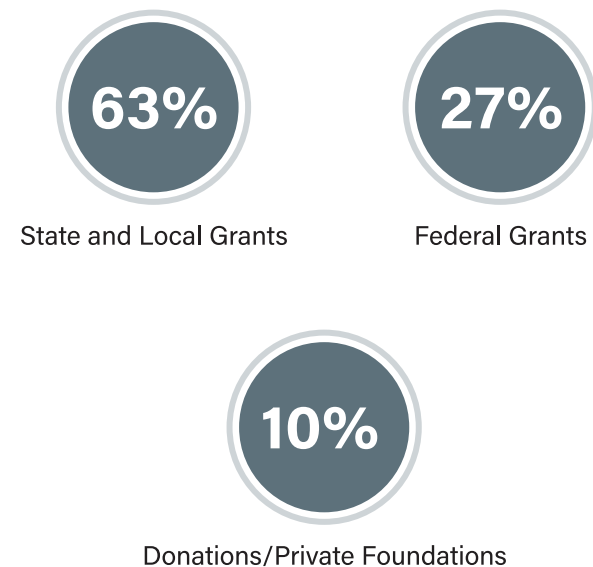

Santa Fe Recovery Center is a 501(c)(3) nonprofit organization that has been providing compassionate treatment to support people throughout their full journey of recovery from addiction, substance use, and related mental illness since 2005.

In Spring 2020, at the request of the State of New Mexico Department of Health and the New Mexico Human Services Department, Santa Fe Recovery Center was tapped to fill the void in evidence-based SUD treatment options in McKinley County. In December 2020, Santa Fe Recovery Center opened Four Corners Detox Recovery Center (FCDC) in Gallup, NM, in an effort to help eliminate the gaping health disparities in this rural, underserved community.
